Sex Offenders, Stigma, and Social Control-Diana Rickard 2016-07-12 The 1990s witnessed a flurry of legislative initiatives—most notably, “Megan’s Law”—designed to control a population of sex offenders (child abusers) widely reviled as sick, evil, and incurable. In Sex Offenders, Stigma, and Social Control, Diana Rickard provides the reader with an in-depth view of six such men, exploring how they manage to cope with their highly stigmatized role as social outcasts. The six men discussed in the book are typical convicted sex offenders—neither serial pedophiles nor individuals convicted of the type of brutal act that looms large in public perceptions about sex crimes. Sex Offenders, Stigma, and Social Control makes a significant contribution to our understanding of sex offenders, offering a unique window into how individuals make meaning out of their experiences and present a viable—not monstrous—social self to themselves and others.

Stigma-Robert M. Page 2015-06-19 Although references to stigma were commonplace in the field of social policy and elsewhere, the concept was often used in a rather imprecise way. Originally published in 1984, this book assesses the relevance of the concept of stigma for the study of social policy. Investigations of the concept within the welfare field have tended to be far too narrow in focus (i.e. the concept has been regarded as a technical problem which can be eradicated by greater adherence to the principle of universalism). As a counter to this perspective, Robert Page argues that it is necessary to distinguish much more clearly between various aspects of the concept of stigma (e.g. stigmas, stigmatization and

felt stigma). He examines the reasons why, and the ways in which, one particular ‘welfare’ group – unmarried mothers – have been stigmatized over the centuries in order to highlight the importance of examining existing patterns of ‘welfare’ and other forms of stigmatization within their political, economic, social and historical context. It is concluded that stigma will continue to be a key concept for both students and practitioners within the field of social policy provided that it is examined from this wider perspective.

Disability, Stigma, and Children’s Developing Selves-Misa Kayama 2019-12 Guided by developmental cultural psychology, this volume focuses on understandings and responses to disability and stigmatization from the perspectives of educators practicing in Japan, South Korea, Taiwan, and the United States. Synthesizing research that spanned over a decade, this volume seeks to understand disabilities in different developmental and cultural contexts. The research presented in this book found that educators from all four cultural groups expressed strikingly similar concerns about the impact of stigmatization on the emerging cultural self, both with children with disabilities and their typically developing peers, while also describing culturally nuanced socialization goals and practices pertaining to inclusive education. In providing a multicultural view of common challenges in classrooms from around the world, this book provides important lessons for the improvement of children’s lives, as well as the development of theory, policy, and programs that are culturally sensitive and sustainable.

The Social Psychology of Stigma-Todd F. Heatherton 2003-07-16 The volume demonstrates that stigma is a normal - albeit undesirable - consequence of people’s limited cognitive resources, and of the social information and experiences to which they are exposed. Incorporated are the perspectives of both the perceiver and the target; the relevance of personal and collective identities; and the interplay of affective, cognitive, and behavioral processes. Particular attention is given to how stigmatized persons make meaning of their predicaments, such as by forming alternative, positive group identities.

Critical Reflections on Women, Family, Crime and Justice-Masson, Isla 2021-05-18 Drawing on research from the Women, Family, Crime and Justice research network, this collection sheds new light on the experiences of women and families who encounter the UK criminal justice system. Contributions demonstrate how these groups are often ignored, oppressed and victimised, and offer insights and practical recommendations for change.

The Role of Gender in Experiences of Substance Use-related Stigma and Injection Drug Use Initiation Processes-Stephanie Alice Meyers 2020 Background: Women who inject drugs (WWID) are disproportionately impacted by injection-related harms and substance use-related stigma. Guided by an integration of the Stigma and Substance Use Process Model and the Risk Environment Framework, this dissertation sought to further elucidate the impact of gender on substance use stigma and injection drug use trajectories. Methods: This dissertation includes a systematic review of substance use-related stigma (Chapter 2) and mixed methods analyses from three prospective cohorts of people who inject drugs (PWID) linked within the PReventing Injecting by Modifying Existing Responses (PRIMER) study. Cohorts provide data from San Diego, USA (n = 352) (Chapter 3), Vancouver, Canada (n = 1,739) (Chapters 3 & 4), and Tijuana, Mexico (n =531) (Chapters 3 & 4). Chapter 2 systematically reviews the scientific literature on the intersection of gender- and substance use-related stigma. Chapter 3, using a mixed methods approach, examines how gender influences the risk environment for processes of injection initiation. Chapter 4 applies discrete time survival analyses to assess the association between gender and the provision of first-time injection initiation assistance. Results: Of the 75 articles (Quantitative: n = 40; Qualitative: n = 35) included in Chapter 2, 23(57.5%) quantitative articles reported no association between gender and substance use-related stigma, whereas 34(97.1%) qualitative articles reported women experienced greater substance use stigma than men. Chapter 3 findings demonstrated a greater proportion of gender concordant (e.g., male-male vs. male-female) ‘assister’ and ‘assistee’ injection initiation pairs among PWID in Tijuana compared to Vancouver or San Diego. The gendered spatial risk environment of prisons/jails in Tijuana and social risk environments of intimate partnerships and caring in San Diego and Vancouver, respectively, likely explain differences in gender concordance of assister-assistee pairs by setting. Chapter 4 findings demonstrate that, compared to WWID, women were nearly 50% less likely to provide first-time injection initiation assistance in Tijuana, but not in Vancouver. Conclusions: These findings illustrate the need for intersectional approaches to research on the influence of gender on stigma- and injection drug use-related processes. Furthermore, these results can inform the development of critically needed gender- and site-specific injection prevention and intervention efforts.

Enhanced Beings-Kerry Lynn Macintosh 2018-08-31 Explains how and why laws against human germline modification will do more harm than good.

Stigma Cities-Jonathan Foster 2018-09-27 Growing up in Birmingham, Alabama, a city that he loved, Jonathan Foster was forced to come to grips with its reputation for racial violence. In so doing, he began to question how other cities dealt with similar kinds of stigmas that resulted from behavior and events that fell outside accepted norms. He wanted to know how such stigmas changed over time and how they affected a city’s reputation and residents. Those questions led to this examination of the role of stigma and history in three very different cities: Birmingham, San Francisco, and Las Vegas. In the era of civil rights, Birmingham became known as “Bombingham,” a place of constant reactionary and racist violence. Las Vegas emerged as the nation’s most recognizable Sin City, and San Francisco’s tolerance of homosexuality made it the perceived capital of Gay America. Stigma Cites shows how cultural and political trends influenced perceptions of disrepute in these cities, and how, in turn, their status as sites of vice and violence influenced development decisions, from Birmingham’s efforts to shed its reputation as racist, to San Francisco’s transformation of its stigma into a point of pride, to Las Vegas’s use of gambling to promote tourism and economic growth. The first work to investigate the important effects of stigmatized identities on urban places, Foster’s innovative study suggests that reputation, no less than

physical and economic forces, explains how cities develop and why. An absorbing work of history and urban sociology, the book illuminates the significance of perceptions in shaping metropolitan history.

Stigma Revisited-Stacey Hannem 2012-10-06 Stigma Revisited: Implications of the Mark is a collection of qualitative, empirical studies of populations who experience stigma. Discrimination, marginality and social injustice are recognized as indelibly tied to the phenomena of stigma. This volume builds on the work of Erving Goffman and integrates a larger, structural understanding of stigma based in Michel Foucault’s governmentality writings. Contemporary notions of risk, riskiness and danger are linked to the labelling of “deviant” populations in the name of social control and risk management; these labels result in the institutional and systemic perpetuation of stereotypes and stigmatic attitudes. The research presented in this book addresses the individual experience of symbolic stigma as well as the collective impact of structural stigma. Justice in Conflict-Mark Kersten 2016-06-24 What happens when the international community simultaneously pursues peace and justice in response to ongoing conflicts? What are the effects of interventions by the International Criminal Court (ICC) on the wars in which the institution intervenes? Is holding perpetrators of mass atrocities accountable a help or hindrance to conflict resolution? This book offers an in-depth examination of the effects of interventions by the ICC on peace, justice and conflict processes. The ‘peace versus justice’ debate, wherein it is argued that the ICC has either positive or negative effects on ‘peace’, has spawned in response to the Court’s propensity to intervene in conflicts as they still rage. This book is a response to, and a critical engagement with, this debate. Building on theoretical and analytical insights from the fields of conflict and peace studies, conflict resolution, and negotiation theory, the book develops a novel analytical framework to study the Court’s effects on peace, justice, and conflict processes. This framework is applied to two cases: Libya and northern Uganda. Drawing on extensive fieldwork, the core of the book examines the empirical effects of the ICC on each case. The book also examines why the ICC has the effects that it does, delineating the relationship between the interests of states that refer situations to the Court and the ICC’s institutional interests, arguing that the negotiation of these interests determines which side of a conflict the ICC targets and thus its effects on peace, justice, and conflict processes. While the effects of the ICC’s interventions are ultimately and inevitably mixed, the book makes a unique contribution to the empirical record on ICC interventions and presents a novel and sophisticated means of studying, analyzing, and understanding the effects of the Court’s interventions in Libya, northern Uganda - and beyond.

The Rise and Fall of Meter-Meredith Martin 2012-05-06 Why do we often teach English poetic meter by the Greek terms iamb and trochee? How is our understanding of English meter influenced by the history of England’s sense of itself in the nineteenth century? Not an old-fashioned approach to poetry, but a dynamic, contested, and inherently nontraditional field, “English meter” concerned issues of personal and national identity, class, education, patriotism, militarism, and the development of English literature as a discipline. The Rise and Fall of Meter tells the unknown story of English meter from the late eighteenth century until just after World War I. Uncovering a vast and unexplored archive in the history of poetics, Meredith Martin shows that the history of prosody is tied to the ways Victorian England argued about its national identity. Gerard Manley Hopkins, Coventry Patmore, and Robert Bridges used meter to negotiate their relationship to England and the English language; George Saintsbury, Matthew Arnold, and Henry Newbolt worried about the rise of one metrical model among multiple competitors. The pressure to conform to a stable model, however, produced reactionary misunderstandings of English meter and the culture it stood for. This unstable relationship to poetic form influenced the prose and poems of Robert Graves, Siegfried Sassoon, Wilfred Owen, W. B. Yeats, Ezra Pound, and Alice Meynell. A significant intervention in literary history, this book argues that our contemporary understanding of the rise of modernist poetic form was crucially bound to narratives of English national culture.

Discrimination as Stigma-Iyiola Solanke 2016-12-29 This monograph reconceptualises discrimination law as fundamentally concerned with stigma. Using sociological and socio-psychological theories of stigma, the author presents an ‘anti-stigma principle’, promoting it as a method to determine the scope of legal protection from discrimination. The anti-stigma principle recognises the role of institutional and individual action in the perpetuation of discrimination. Setting discrimination law within the field of public health, it frames positive action and intersectional discrimination as the norm in this field of law rather than the exception. In developing and applying this new theory for anti-discrimination law, the book draws upon case law from jurisdictions including the UK, Australia, New Zealand, the USA and Canada, as well as European law.

Conscience in Reproductive Health Care-Carolyn McLeod 2020-04 Conscience in Reproductive Health Care responds to the growing worldwide trend of health care professionals conscientiously refusing to provide abortions and similar reproductive health services in countries where these services are legal and professionally accepted. Carolyn McLeod argues that conscientious objectors in health care should prioritize the interests of patients in receiving care over their own interest in acting on their conscience. She defends this “prioritizing approach” to conscientious objection over the more popular “compromise approach” without downplaying the importance of health care professionals having a conscience or the moral complexity of their conscientious refusals. McLeod’s central argument is that health care professionals who are gatekeepers of services such as abortions are fiduciaries for their patients and for the public they are licensed to serve. As such, they owe a duty of loyalty to these beneficiaries and should give primacy to their beneficiaries’ interests in accessing care. This conclusion is informed by what McLeod believes is morally at stake for the main parties to the conflicts generated by conscientious refusals: the objector and the patient. What is at stake, according to McLeod, depends on the relevant socio-political context, but typically includes the objector’s integrity and the patient’s interest in avoiding harm.
